You are invited to participate in the annual CSI Swimposium weekend. It will include workshops on Saturday, the CSI Awards Banquet on Saturday evening, and the House of Delegates Meeting on Sunday morning. The only cost for the Swimposium is the banquet.

Club Development Clinic: Tom Avischious from USA Swimming will take you through the dos and don'ts of club management. Every club will benefit from this presentation and should send someone from their club to this clinic. It is a requirement for all new clubs.

Officials Clinic: Dan McAllen a long time USA Swimming official will conduct an official's clinic. All officials are invited to attend, morning session for S&T, afternoon Starters and Referee's. We will have a new official's clinic in the morning as well.

Parents Clinic: Scott Allen will present a clinic for parents; he will walk you through all the aspects of being a swim parent.

Athlete Clinic: The clinic will take place at the Meyers Pool, 7900 Carr Dr. in Arvada. The morning session will be for 12 & Under's and the afternoon session for 13&Overs, all swimmers participating in the clinic must be current members of USA/CSI.

Coaches Clinic: Scott Colby from USA Swimming will give a presentation of stroke mechanics in the morning with a coach's forum in the afternoon to discuss issue's concerning Colorado Swimming. Todd Schmitz will recertify coaches for the up coming year.

The all day clinics will break for lunch, everyone is on their own for lunch. See the schedule below.

CSI Awards Banquet: Awards will be presented for Athlete of the Year, male, female, and seasonal athlete. Coach of the Year, coach, age group coach, and seasonal coach. Official of the Year, and USA Swimming Outstanding Service Award will also be presented. Certificates will be given to CSI record breakers. The cost of the dinner is \$15.00 per person.

House of Delegates Meeting: House of Delegates meeting is the annual report from the C.S.I Board of Directors to the members of Colorado Swimming, Inc. At this meeting we will elect members of the C.S.I. Board of Directors, Board of Review and Nominating Committee. Adopt the annual budget, and ratify or rescind policy and programs established by the Board of Directors. Each Group Member in good standing shall appoint from its membership three (3) Group Member Representatives of which one (1) must be an Athlete Member for voting purposes. If you are planning to attend the House of Delegates meeting check with your club to see if you have one of their votes. Again this year we will be giving a door prize, entries for the drawing will be taken at the banquet and the drawing will take place at the House of Delegates Meeting. One club membership and five non-athlete memberships, a \$400.00 value, will be given away. Each club can have three entries but must have three people at the banquet to register and one person from your club must be present at the drawing to win.
